



STOCK & MUTUAL FUND DONATION INSTRUCTIONS

Thank you for considering a donation of stock or mutual funds to Allegheny Center Christian & Missionary Alliance Church (ACAC). We appreciate your generous financial support.

Please note that donations must be received into ACAC's account by December 31 to receive a tax deduction for the calendar year.

Mutual Fund Donations: If you would like to donate mutual funds, please contact your mutual fund company first. Each mutual fund company has specific procedures for charitable donations. Thank you.

Stock Donations: ACAC has an account under the name of Allegheny Center Christian and Missionary Alliance Church at TD Ameritrade, Inc., account # 781-011488, DTC # 0188 (for wiring), and Tax ID # 25-1048750. Below are specific instructions for transferring stock.

Wiring Stock:

- 1) Donors should write a letter requesting that their brokerage firm transfer the stock or securities to Allegheny Center Christian & Missionary Alliance Church's TD Ameritrade account # 781-011488, DTC # 0188. Please see sample letter below. **Please use ACAC's full name, Allegheny Center Christian & Missionary Alliance Church, on all correspondence related to the transfer.**
- 2) Please complete the Donor Designation Form below and return it to Karen Allerton at Karen.Allerton@acac.net. For a list of funds available for designation, please see below.

Transferring a Stock Certificate:

- 1) The donor (all owners in whose name the stock is registered) must sign a Third-Party Release form and have it signature guaranteed by a bank or brokerage firm (the donor needs to sign the form in the presence of the person signature guaranteeing the form). The donor(s) also needs to sign the back of the stock certificate and appoint "TD Ameritrade Inc" as attorney on the back of the certificate. Write ACAC's account # 781-011488 on the front of the certificate (anywhere in the margin). **Please use ACAC's full name, Allegheny Center Christian & Missionary Alliance Church, when registering shares in ACAC's name and on all correspondence related to the transfer.**
- 2) Donor should give stock certificate and signature guaranteed letter to Karen Allerton, ACAC Finance Manager.
